

Town Of Lovell
Selectmen's meeting minutes April 27th, 2010

Attendance- Bob Drew, Turf Ramsden, and Stephen Goldsmith. Larry Fox, Scott Davidson and Scott Gardiner.

1. We gave Turf the Health Benefits and waived the waiting period since he has been a long-time employee of the Town.
2. MMA received the grant Steve filled out and will notify us in May.
3. Received an email from Karen Gulbrandsen requesting a sign at both ends of Kimball Rd since her grandson is legally blind. Larry will look into this and order the signs.
4. The minutes were accepted from last week. Bob made the motion and Turf seconded it. All voted in favor.
5. Bob wrote the letter in support of the Dental Clinic in Bridgton as discussed last week.
6. We discussed the GLLT's request for monies from the Eastman Hill Fund. Steve said that he would like to see monies available to pursue the fixing of the Town Hall and would rather see the Town give monies for this especially, if we get a matching grant. Steve made the motion not to support applying to the Eastman Hill Fund for the GLLT's request for the Amos mountain trail. Turf seconded this and we all voted in favor. We did want to note that we think this is a great project.
7. We discussed that there was some new monies taken off the tax roles because the Croonquist's have deeded some of their properties as tax exempt.
8. Bob received an email back from the DEP in regards to the Korth's project on Eastman Hill. He sent them to the Korth's. They now would like a written plan drawn up. Bob will work on this.
9. We discussed the new softball field at the Rec field. It is too rough and we need to try to smooth it out. Larry will attempt to roll it. If this does not work we might have to re-till the area and reseed it. The grass has not come in very well. We might contact Rick in the fall since he did this project.
10. Larry met with Bruce Manzer regarding the roads and road plans. He will be working with Larry to give us a quote.
11. Bob called about getting cable at the Town Office, Transfer Station and School.

12. We reviewed some figures regarding the transfer station and we will set up a meeting with Stow and Chatham May 11th.
13. Larry is working on getting a quote for screens at Cushman Pond dam.
14. The Cemeteries are almost all raked.
15. Double T Fence was cheaper than Bancroft so we will use them.
16. We signed two concealed weapon permits.
17. Mark Moulton came in to discuss the septic system at the fire station. It has failed. Bob has contacted Bliss as well as Mike Friedman to see if we can get some land from Prescott's to redesign this.
18. We received the Maine Policy Review Magazine.
19. Larry talked about the docks at the Narrows. J Mack dock will be contacted. The North Lovell docks are in.
20. Turf will attend a DEP workshop in Portland Friday.
